# DECLARATION OF KIMBERLY DONALDSON-SMITH IN SUPPORT OF PLAINTIFFS' RESPONSE IN OPPOSITION TO WALMART INC. AND WALMART.COM USA, LLC'S MOTION TO DISMISS

- I, Kimberly Donaldson-Smith, declare as follows:
- 1. I am a partner of Chimicles Schwartz Kriner & Donaldson-Smith LLP ("CSKD" or the "Firm"), and one of the attorneys of record for Plaintiffs. I submit this declaration in support of Plaintiffs' Response in Opposition to Walmart Inc. and Wal-Mart.Com USA, LLC's Motion to Dismiss, D.I. 20 ("Motion"). I submit this declaration based on personal knowledge, and if called to do so, could testify to the matters contained herein.

#### A. Amended Schedule 2

2. Paragraph 35 of the Complaint identifies Schedule 2 (which was filed with the Complaint, D.I. 1-2): "Schedule 2 provides a detailed depiction, through screenshots, of the Fraudulent Sellers' fraudulent Product Pages on Walmart Marketplace and the corresponding

product listings by the Amazon Merchants (including certain of the Plaintiffs' listings) on Amazon.com." The as-filed version of Schedule 2 has an index of the screenshots by "tab" reference; however, the "tabs" were inadvertently omitted from the filed version. Attached is an Amended Schedule 2, amended solely to add the "tab pages", to aid in referencing the screenshots.

#### B. Update to Number of Sellers and SKU Count on Marketplace

3. The following was stated by John David Rainey, Walmart, Inc.'s Chief Financial Officer & Executive Vice President, during Walmart's Third Quarter Fiscal Year 2025 Earnings Call, concerning the SKU counts and number of sellers on the Marketplace:

For marketplace and Walmart fulfillment services, in the US, marketplace grew 42% in Q3, and we've now seen more than 30% growth in each of the past 5 quarters. The number of sellers on the platform continued to grow double digits, and SKU count is approaching 700 million items, with a broader assortment of the brands and items customers want, marketplace sales in beauty, toys, hardlines and home all grew more than 20%. We continue to leverage our next-generation supply chain and technology to provide fulfillment for sellers at some of the lowest rates in the industry. As a result, more sellers are using our marketplace fulfillment services with WFS sales penetration reaching record highs at more than 40%.

#### C. When Mr. Simister First Contacted Walmart About the ORC

4. Paragraph 557 of the Complaint begins with this statement: "Beginning in January of 2021, Mr. Simister, owner of Plaintiff Artistic Industries, reached out to Walmart to inform it of the ORC." The "2021" reference is a typo. Mr. Simister believes that he first communicated with Walmart in mid-2022.

#### D. Marketplace Operates in California

- 5. The Marketplace operates in California, as demonstrated by the following publicly available information:

#### E. Language Added "About Seller" Post-Complaint

- 6. After the Complaint was filed, Walmart added the following language to the "About Seller" page: "This seller may use a different seller to supply a consumer product to consumer upon purchase."
  - This seller may also engage in manufacturing, importing or reselling consumer products. This seller may use a different seller to supply a consumer product to consumer upon purchase.

#### F. Post-Complaint Listings of Plaintiffs' Products

- 7. Since the Complaint was filed, the Plaintiffs' products continue to be listed on Walmart Marketplace by non-authorized third-party sellers. In an effort to mitigate damages and to protect Plaintiffs' business, Plaintiffs' counsel provided Walmart with (a) the identities of the third-party sellers on the Marketplace whose Seller StoreFronts, Seller Catalogs, and Product Pages contained unauthorized listings of Plaintiffs' products after the Complaint was filed, and (b) details of Fraudulent Amazon Orders and Fraudulent Refund Requests occurring after the Complaint was filed, that were confirmed to have originated with a sale on the Marketplace by a suspected Fraudulent Seller.<sup>1</sup>
- 8. By way of example only, just looking on the Marketplace on walmart.com on February 7, 2025 (and not exhaustively as to what appeared on that date in terms of the Plaintiffs' products), the following listings by suspected Fraudulent Sellers appeared:

#### a. My Nik is Sealed "Sold and Shipped by panzanmaoyi02"

On February 7, 2025, a listing for a 3 Pack of My Nik is Sealed was appearing on Walmart Marketplace. It was identified with a fake Brand name of "JKALHFDJ", being sold and shipped by the StoreFront "panzanmaovi02", with Walmart Seller number 102511808, whose business name is "zaoyangpanzanmaoyiyouxiangongsi", and address:
