MEMORANDUM OF LAW IN SUPPORT OF PLAINTIFF-APPELLANT UNITED STATES' UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF

Counsel for Plaintiff-Appellant United States respectfully moves for a 45-day extension of time to file its opening brief, from March 10, 2025 to April 24, 2025. eBay does not oppose this motion. The United States understands and appreciates that extensions of time are highly disfavored. *See* Local Rule 27.1(f). For the following reasons, however, the United States respectfully submits that an extension is needed and that extraordinary circumstances exist that warrant an extension here. In support of its request, Appellant states as follows:

- 1. In the underlying case, the United States brought a civil enforcement action against eBay for the sale, offering for sale, and distribution in commerce of illegal products under the Clean Air Act (CAA), Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), and the Toxic Substances Control Act (TSCA), based on thousands of alleged violations of these statutes. The district court granted eBay's motion to dismiss, finding that eBay's alleged actions did not qualify for potential liability under the CAA and FIFRA, that the United States' Complaint by contrast stated a claim under TSCA, but that eBay was immune from suit on the TSCA claim under section 230 of the Communications Decency Act.
- 2. Both the immunity and statutory issues presented in this appeal are important and legally complex. In addition, the underlying question implicated by the appeal—whether and under what circumstances entities like eBay can be held liable for unlawful sales conducted on their platforms—is significant and potentially far-reaching.
- 3. In addition, the Solicitor General of the United States must authorize all appeals to the lower appellate courts in cases handled by divisions of the Department of Justice and United States Attorneys. *See* 28 C.F.R. § 0.20(b). The Acting Solicitor General has not yet determined whether to authorize this appeal. Due both to the complexity of this case and the press of other matters—including numerous decisions and matters associated with the recent change in

Administration—the government requires additional time to determine whether to authorize the appeal in this case and, if appeal is authorized, to determine what issues the United States will raise on appeal.

- 4. In addition, if appeal is authorized, the United States' brief will need to be reviewed by, among others, the Office of the Solicitor General, the Front Office of the Environment and Natural Resources Division, trial counsel, the United States' Attorney's Office for the Eastern District of New York, the Environmental Protection Agency, and any other affected agencies and components.
- 5. Given all of these considerations, additional time is needed for the United States to determine whether to pursue this appeal as well as what issues (if any) to raise on appeal and—if appeal is authorized—to prepare, finalize, and file the United States' opening brief.
- 6. Under the circumstances, no party will be prejudiced by the requested extension. Counsel for eBay has informed counsel for the United States that eBay does not oppose this motion. And since the United States is both the Appellant in this Court and the Plaintiff below, no other party is seeking substantive relief in this action or on appeal.
- 7. Consistent with Local Rule 27.1(f)(3), the United States is filing this motion as soon as practicable after it became apparent that the extraordinary circumstances discussed above necessitated an extension.

8. Consistent with Local Rule 27.1(f)(2), the United States has not filed a previous extension motion, but did file a motion to remove this case from the expedited appeals calendar, which was granted. There have been no prior orders stating that no extension would be allowed.¹

9. For the foregoing reasons, the United States respectfully requests that the Court extend the time to file its opening brief from March 10, 2025, to April 24, 2025.
